

2020 White Spot & Triple O's 1000 Free Impossible™ Burger Giveaway Contest

OFFICIAL RULES AND REGULATIONS

Open to residents of British Columbia & Alberta only.

Please read these official contest rules (the "Rules") in their entirety before entering this contest (the "Contest") offered by White Spot & Triple O's (the "Sponsor"). Do not enter the Contest unless you agree to these Rules. Participation in the Contest constitutes full and unconditional agreement and acceptance of these Rules which are final on all matters relating to the Contest.

1. HOW TO ENTER THE CONTEST: Entrants must enter the Contest by submitting an Online Entry (each defined below) following the method(s) set forth in this paragraph. No purchase is necessary to enter the Contest. Max 1 entry per person, per each White Spot & Triple O's contest pages. To enter through White Spot Restaurants, entrants must fill out the form on the White Spot website. To enter through Triple O's Restaurants, entrants must fill out the form on the Triple O's website. Winners will be drawn weekly, with all winners contacted by October 25, 2020.

2. CONTEST ELIGIBILITY: The Contest is open only to residents of British Columbia or Alberta 19 or older at the time of entry who possess a valid driver's license, and excludes all employees (current and retired) of White Spot & Triple O's, its advertising and promotional agencies, associated entities and subsidiaries, affiliates, representatives and agents of the aforementioned parties, and a member of any such employee's immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). 4. PRIZE DESCRIPTION: There are a total of one thousand (1000) FREE Impossible Burger prizes to be won – 500 available via White Spot & 500 available via Triple O's. White Spot prize includes 1 Free Avocado Impossible Burger platter meal valued at \$17.99+tax (Burger, fries & coleslaw). Triple O's prize includes 1 free Original Impossible Burger (Burger only) valued at \$8.99+tax. Total approximate value of all prizing is \$13,490+tax. Toppings & substitution charges may apply. No cash value. Non-transferable. Should multiple people win within the same party or family, only one prize may be redeemed per visit.

RANDOM DRAW, AWARDING & DELIVERY OF THE PRIZES: One thousand (1000) total eligible prize winners will be selected by random draw from all eligible entries received on each contest page (500 from Triple O's & 500 from White Spot) over the course of 5 weeks (100 winners selected weekly per each White Spot & Triple O's). Winners will be contacted by mail with their prize enclosed. Only the winners will be contacted. The prize will be awarded in the form of a physical certificate mailed to the winner's address as entered on the form.
